The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 26/05/2017 (F/N) by the undersigned in presence of shri Prashanth Sabarad, Lessess son.

Rule	Nature of Violation observed
11(1)	The mining operations in the lease area are not carried out as per approved mining plan and following deviations are observed during inspection. a) In the approved mining plane it was proposed to dump waste in the south western part of the lease area near pillar no-2. However on day of inspection it was observed that OB was dumped in the North-western part of the lease area near pillar no-3. b) Mineral was stacked in the south western part of the lease area where there is no such proposal in the approved scheme of mining.
26(2)	An yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted for the year 2015-16 so far.
55(3)(iii)(iv)	The Mining engineer and Geologist required under the said rule are not appointed by the lessee.
67	A self appraisal note to be submitted by the mines owner/lessee stating extent of implementation of approved minig plan/scheme of mining during the year 2015-16 along with supporting plan & sections ,representative photographs is not

submitted to this office so far in hard as well as soft copy.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
