45(5)(c)	Annual returns for the year 2014-15 and 2015-16 is not submitted to this office so far.
46(b)	Notice of termination of Shri Venkatesh Subhas, Geologist is not submitted.
55(3)(iii)(iv)	The Mining engineer and Geologist required under the said rule are not appointed by the lessee.
67	A self appraisal note to be submitted by the mines owner/lessee stating extent of implementation of approved minig plan/scheme of mining during the year 2015-16 along with supporting plan & sections ,representative photographs is not submitted to this office so far in hard as well as soft copy.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under Rule 45(7)(a)(i), if compliance of rule 45 is not found satisfactory.
- 04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
