Subject:- Violation of provisions of MCDR 2017 in respect of Venkatagiri Iron Ore Mine (M.L. No. 2551) of M/s Lakshmi Minerals, over an extent of 21.73 ha in Venkatagiri Village, SandurTaluk, Bellari district, Karnataka State...Reg.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017 were found violated in your above mine during the inspection on 27/02/2018 by undersigned in the presence of Mines Manager ShriObulla Reddy.

Rule	It was proposed in approved Review & Updation of Mining Plan approved vide letter No.
11(1)	279/783/2004/BNG dated 9/11/2016 for the period 2017-18 to 2021-22 The deviations
	observed in mining operations vis-a-vis approved document are given below:
	It was proposed and approved in chapter Mining, table-no.34, under year wise production & development, with note that the ore production will yield about 70% fines (-10mm) & remaining 30% will be lumps with a lumps to fines ratio of 30:70.
	But during the filed visit on 27/02/2018, it was observed that the lump to fines ratio indicated is not matching with the developed pit benches & production made in these benches, reveals 45 to 50% lumps and the fines of around 50%. Thereby, the lump to fines ratio projected in the approved document is not correct and may likely vary to 45:55 in the present situation. Hence the document needs to be modified accordingly.

(b) (i)	assurance is not matching, which needs to be attended suitably and correctly.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 03. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
