Sub:- Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of your Yadwad Limestone Mine M.L.No-2500 over an area of 54.156Ha.situated in Yadwad-Village, Taluka-Gokak Distt.-Belgaum, of Karnataka-State Dear Sir,

The following provision of Mineral Conservation & Development Rules, 1988 was found violated during the inspection of your above mine on 30/08/2013 by the undersigned.

13(1)	The mining operations are not carried out as per approved scheme of mining dated-02/5/2012 to the extent indicated below. (a) Exploration-It was proposed to drill 04 No. of exploratory boreholes up to 50m depth as earmarked in plate no 3 during the year 2012-13 of approved mining scheme but it was observed during inspection that proposed exploratory bore holes have not been drilled.
45(5)(b)	An annual return for the year 11-12 & 2012-13 which shall be submitted before the 1 st July of the preceding financial year in the prescribed form-H-8 but in your case you have submitted the said return with following deficiencies as given below-Part-I (i) lease area utilization details & employment of wages incorrect & left blank. Part-II,III & IV left blank. Part-V details are incorrect & left blank. Part-VI made correction & dispatch column left blank & Part-VII missing.
29	The owner, agent, mining engineer or manager of mine shall submit the copy of plan & section on or before the 30 th June of every year but you have not submitted the updated plan & section maintained under rule 28 to this office till date.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988. The relevant extract of the rule 58 is given below:

Contd.-2

"58 Penalty: - Whoever contravenes any of the provisions of these rule shall be punishable with imprisonment for a term which may extend up to **two years**, or with fine extending to **fifty thousand rupees** or with both, and in the case of continuing contravention with an additional fine which may extend up to **five thousand rupees** for every day during which such contravention continues, after conviction for the first such contravention. Provided that for repeated contravention the punishment should be in the form of imprisonment only".

In this connection it is once again brought to your notice that the non-compliance of above violation, under rule 45(7) (1) MCDR 1988 (Revised MCDR.2011) the following action may be initiated:

- 01. All mining operation may be suspended.
- 02. Take action to initiate prosecution under these rules.
- 03. It may be recommended for termination of mining lease to the State Government.

Further the violation of Rule 13(1) of MCDR may also attract provisions of Rule 13(2) of MCDR 1988 regarding suspension of mining operations.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
