The following provision of Mineral Conservation & Development Rules, 1988 was found violated during the inspection of your above mine on 08.06.2013 by Shri B. A. Patil, Assistant Mining Geologist.

13(1)	The mining operations has not been carried out as per approved scheme of mining vide letter noMSH/MAN-145(KNT)/GOA/2008-09 dated 08.07.2008				
	 a) In the approved Scheme of Mining for plan period of 2008-09 to 2012-13, the production and development proposal were made leaving 7.5 m of safety barriers with benches of the pit of 3m hight. However, the pit has been extended outside the lease area and benches are of more than 3m height thus deviating from the proposals. b) It was proposed to drill 3 & 2 boreholes of 25m depth each in the year 2008-09 and 2009-10 respectively. These boreholes have not been drilled during the plan period. c) As per the mining scheme plantations were proposed in the safety barrier area. However, it is reported that plantation was undertaken around office which is located outside the lease area. 				
42	A part time or whole time geologist or mining engineer have not been employed as prescribed under sub clauses of the said rule.				

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988.
- 03. The mining operations will be suspended under rule 13(2) of MCDR-88, if the compliance of violation of rule 13(1) is not found satisfactory.

You are advised to rectify the violation immediately and intimate the position to this office within a period of 45(Forty Five) days from the date of issue of this letter.
