Sub.- Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of your Karadigudda Dolomite Mine M.L.No-2275, Area-4.04Ha. situated in Karadigudda Villages, Badami-Taluka Distt.-Bagalkot, Karnataka-State

Dear Sir,

The following provision of Mineral Conservation & Development Rules, 1988 was found violated during the inspection of your above mine on 04/06/2013 by the undersigned.

42(1)(c)(ii)	A whole time or a part time mining engineer / Geologist have not been employed for the purpose of carrying out mining operations in accordance with these rules.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988. The relevant extract of the rule 58 is given below:

“58 Penalty: - Whoever contravenes any of the provisions of these rule shall be punishable with imprisonment for a term which may extend up to **two years**, or with fine extending to **fifty thousand rupees** or with both, and in the case of continuing contravention with an additional fine which may extend up to **five thousand rupees** for every day during which such contravention continues, after conviction for the first such contravention. Provided that for repeated contravention the punishment should be in the form of imprisonment only”.
