The following provisions of Mineral Conservation and Development Rules, 1988 amended up to 2011 were found violated in your above mine during the inspection on 19.6.2013 by Smt.Ch. Suseela, Assistant Mining Geologist of this office.

Rule	Nature of Violation observed
13(1)	The Mining operations are not being carried out as per the approved Scheme of mining approved vide letter No.6013/MS-KNL/2011 dated 27.12.2011 for the period 2011-12 to 2015-16 as given below:
	Against proposal of mining operations by manual method, the mining operations were being carried out by deploying machinery such as excavator and tippers etc
02. It is again brought to your notice that non compliance of the provisions of Rule 13(1)	
& non- submission of returns attracts provisions of Rule 13(2) of MCDR, 1988	
(Amended), of MCDR, 1988 which leads to order of suspension of mining	
operations and these violations also constitutes an offence punishable under Rule-58	
of MCDR, 1988.	

- 03. You are, therefore, directed to **Show Cause** within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence or the mining operations should not be suspended under rule 13(2) of MCDR,1988
- 04. Please note that no further notice will be given to you in this regard.
