The following provisions of Mineral Conservation and Development Rules 1988 (Amended) up to 2011, were found violated in your above mine based on Office records .

45(5)(b)(viii)	The owner, agent, mining engineer or manager of every mine, shall submit to the Regional Controller of Mines in the Indian Bureau of Mines or any other authorised official of the Indian Bureau of Mines, returns in respect of each mine, in the following manner, namely: (b) an annual return which shall be submitted before the 1st July each year for the preceding financial year in the Form as indicated below:- (viii) for all other minerals in Form H-8: You have not submitted the annual return for the year 2012-13 so far				
42(1)©(ii)	A part time mining engineer has not been employed as the mine to carry out mining operations as required under the rule.				

- 02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988. Besides, inability to comply the provision of rule 45(5)(b)(viii) are also liable for suspension of mining operations under rule 45(7)(i)(a) of MCDR, 1988.
- 03. You are, therefore, directed to show-cause within a period of 30(thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence and or Mining operations shall be suspended under the provision of Rule 45(7)(i)(a) of MCDR, 1988 in the Mine till the compliance of the aforesaid violations.
