Sub.- Violation of provisions of Mineral Conservation and Development Rules, 1988 (MCDR'88) in respect of your Prospecting License for Manganese Ore (8.14 Hect), in Village – Nagardhan, Tahsil – Ramtek, District – Nagpur of Maharashtra State.

Sir.

This has reference to letter no PLV – N/492/2010/2094, dated-03.07.2010 from Directorate of Geology and Mining, Government of Maharashtra regarding above cited PL area granted to you. On examination of our office records, following provisions of MCDR'88 were found violated in respect of the above PL.

Rule No.

Nature of Violation

8(1) Every holder of a prospecting licence shall submit to the Controller General, Controller of Mines and the Regional Controller, an yearly report in Form-B so as to reach them within thirty (30) days after the expiry of twelve months from the date of execution of the prospecting licence or the expiry of the prospecting licence whichever is earlier, and a final report in Form-B within a period of three (3) months after the completion of the prospecting operations or the expiry of the prospecting licence whichever is earlier.

But the yearly report in Form-B has not been received in this office within thirty (30) days after the expiry of twelve months from the date of execution of the prospecting licence. The Final report in Form-B also not received in this office within a period of three (3) months after the expiry of the prospecting licence, thus attracting violation of rule 8 of the MCDR'88.

- 48. Every mine or holder of a prospecting licence shall keep a record in Form K of all shafts or boreholes exceeding ten meters in depth and shall retain all records and samples of the strata passed through for a period of not less than twelve months after the completion of the work or abandonment.
 - But the information of borehole was not available with the licensee in Form K, thus attracting violation of rule 48 of the MCDR'88.
- 59. Every mine or holder of a prospecting licence shall preserve intact all cores and specimen of different types of rocks and minerals obtained during and arrange them to be laid out in a serial order with identification marks, showing the progressive depth at which they are obtained.

But the preservation of cores and specimen of different types of rocks and minerals obtained during the prospecting operation was not available during inspection, thus attracting violation of rule 59 of the MCDR'88.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of the MCDR'88.
- O3. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
