Sub : Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of your Redi Iron ore Mine (Block-I) for an area of 94.7060 Ha ,situated in Redi village,Vengurla- Tq, distt. -Sindhudurg, Maharashtra State.

Dear Sir,

The following provision of Mineral Conservation & Development Rules, 1988 was found violated during the inspection of your above mine on 08/07/2013 by the undersigned.

Rule No.	Nature of violation observed
47	There was a proposal to make 12 bore holes of 900mtrs depth during the year 2012-13. At that time of inspection, accompanying officer informed that, all bore holes has been drilled as per the proposals, but till not been inform in Form-J to Controller General, Controller of Mines and Regional Controller of Mines and is due for submission.
23(E) 2	The owner, agent, manager or mining engineer shall submit to the Regional Controller of Mines a yearly report before 1 st July of every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof. This office has not received the report on the same.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988.

03.You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.

Sub : Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of your Mauli Iron ore Mine of 32.83 Ha, situated in Redi village, Vengurla- Tq, distt. - Sindhudurg, Maharashtra State.

Dear Sir,

The following provision of Mineral Conservation & Development Rules, 1988 was found violated during the inspection of your above mine on 09/07/2013 by the undersigned.

Rule No.	Nature of violation observed
63	Quarterly Environmental Monitoring Reports has not been submitted so far.
23(E) 2	The owner, agent, manager or mining engineer shall submit to the Regional Controller of Mines a yearly report before 1 st July of every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof. This office has not received the report on the same.
42 (1)(c)(i)	As per the Ministry of Mines notification No. G.S.R. 216(E)dated 29/03/2010,a whole time mining engineer has to be employed in the category 'A' mine.The mining engineer should have minimum ten years of professional experience of working in supervisory capacity in the field of mining. On the day of inspection, it is observed that the mine does not have a whole time mining engineer, as per the above provisions of MCDR 1988.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988. The relevant extract of the rule 58 is given below:

“58 Penalty: - Whoever contravenes any of the provisions of these rule shall be punishable with imprisonment for a term which may extend up to **two years**, or with fine extending to **fifty thousand rupees** or with both, and in the case of continuing contravention with an additional fine which may extend up to **five thousand rupees** for every day during which such contravention continues, after conviction for the first such contravention. Provided that for repeated contravention the punishment should be in the form of imprisonment only”.

03.You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
