Sub: Violation of provisions of MCDR, 1988 in respect of your Komorrah Limestone Mine, over an area of 240.55 ha in East Khasi Hills district, Meghalaya.

Sir,

The provisions of the following rules of Mineral Conservation and Development Rules, 1988 (MCDR, 1988) was found violated in your above mine during inspection of the mine on 28/2/2014 by the undersigned.

Rule 12(3): The Scheme of Mining of the mine was approved vide letter No. 314(3)/2008-MCCM(CZ)/S-38, dated 15.09.2009 with validity upto 31.03.2013. The scheme of Mining along with the progressive mine closure plan, for the next five years, should have been submitted 120 days before the expiry of the five years periods for which it was approved in the last occasion.

The scheme of mining along with progressive mine closure plan for the next five years has not yet been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Kolkata which was due on 01.12.2012.

03. The violation of Rule 12(3) of MCDR, 1988 will also attracts the violation of Rule 13(1) of MCDR, 1988 as per the provision of Rule 12(6) of MCDR, 1988.

04. It is brought to your notice that the above violation constitutes an offence punishable under rule 58 of MCDR, 1988.

05. You are therefore, directed to show cause within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence and / or why the mining operation in the mine shall not be suspended under Rule 13(2) of MCDR, 1988 till compliance of the Rule 12(3) of MCDR,1988.

06 Please note that no further notice will be given to you in this regard.
