Sir.

The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above said mine during inspection on 11.05.2013 by the undersigned accompanied by Sri C.B.Das, your representative.

	During inspection, It was reported that the Mine was temporarily discontinued/suspended
24	since year 2009. Whereas Notice of discontinuance in Form D-1 has not been submitted so
	far to the Regional Controller of Mines ,IBM, Bhubaneswar.
45(5)(a)	Monthly Returns for the year 2011-12 onwards have not been submitted so far to the
	Regional Controller of Mines, IBM, Bhubaneswar.
45(5)(b)	Annual Returns for the year 2011-12 onwards have not been submitted so far to the
	Regional Controller of Mines, IBM, Bhubaneswar.

**02.** It is brought to your notice that these violations constitute an offence punishable under Rule 58 of MCDR 1988. The relevant extract of the rule 58 is given below:

"58 Penalty:- Whoever contravenes any of the provisions of these rules shall be punishable with imprisonment for a term which may extend up to two years, or with fine extending to fifty thousand rupees or with both, and in the case of continuing contraventions with an additional fine which may extend up to five thousand rupees for every day during which such contraventions continues, after conviction for the first such contravention. Provided that for repeated contravention the punishment should be in the form of imprisonment only".

Further, failing to submit, the monthly and annual returns under Rule 45(5) (a) &(b) of the Mineral Conservation and Development (Amendment) Rules'1988, resulting in violation of Rule 45(7) of the Mineral Conservation and Development (Amendment) Rules'1988 (MCDR'88), amended vide notification of GSR 75(E) dated 09.02.2011, which leads to suspension of all mining operations in the mine as well as prosecution of the owner, agent and manager.

**03.** You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (forty-five) days** from the date of issue of this letter.
