The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above said mine during inspection on 22.06.2013 by the undersigned, accompanied by Sri. A. Sen, Sr.G.M. (Geology) & Randhir Kumar, Mining Engineer of your mine.

Rule No.	Nature of Violation
13(1)	Mining operations have not been carried out in accordance with the Scheme of Mining approved on dated 08.06.2010 to the extent indicated below :- Ref. Para 6.5, page 6.3 of approved Scheme of Mining; Retaining wall and garland drain have not been constructed all around the toe of the waste dump-D2 near Quarry No 6 & 7 to prevent surface wash off and escape of material.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.

Besides, inability to comply the provision of Rule 13 (1) is also liable for suspension of mining operations according to Rule 13 (2) of MCDR, 1988.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
