The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above said mine during inspection on 24.06.2013 by the undersigned, accompanied by Mr. D. Patel (DGM-Mines) & Mr. S. Mohanty (Principal Geologist) of your mine.

Rule No.	Nature of Violation
13(1)	Mining operations have not been carried out in accordance with the Modification of Scheme of Mining approved dated 30.05.2013 to the extent indicated below: Retaining wall along with garland drain and check dams have not been constructed all around the toe of the Natural Fines stacks No 4 & 5 situated near ML boundary pillar- BP51/7 and Iron Quarry No 6 to prevent surface wash off and escape of material.
42 (1) (C)	Mining Engineer employed i.e. Mr. I.K.Saha is not having ten years of professional experience of working in a supervisory capacity in the field of mining as required under this rule.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.

Besides, inability to comply the provision of Rule 13 (1) is also liable for suspension of mining operations according to Rule 13 (2) of MCDR, 1988.

03. You are advised to rectify the above violations immediately and intimate the position to this office within **45** (forty-five) days from the date of issue of this letter.
