| 33(2)       | In Katasahi Block, Fines Stock/Sub-grade dump No. 20 (located near ML boundary pillar nos. 78 to 81) and Near MDH quarry, Fines Stock No. 31 A (located near ML boundary pillar nos. 31 to 32) have not been properly secured (by retaining wall, garland drain etc.) to prevent escape of material and surface wash-off there from in harmful quantities, which may cause degradation of environment. |

03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 58 of MCDR. 1988.

Besides, inability to comply the provision of Rule 13 (1) is also liable for suspension of mining operations under the provisions of rule 13 (2) of MCDR, 1988.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
