During inspection of Semaria Limestone Mine over an area Of 3.096 hect in village Malapuri Khurd Tahsil Dhamadha District Durg Chhatisgarh state On 19/09/2013, it is observed that the following provision of Mineral Conservation and Development Rules'1988 (MCDR'88), is violated in respect of your above referred mine.

Rule No. Nature of Violation

12(3) The mining scheme of Semaria Limestone Mine over an area Of 3.096 hect in village Malapuri Khurd Tahsil Dhamadha District Durg Chhatisgarh state was due on 1/12/2011 i.e. 120 days before the expiry of your mining plane document, the mining plan of your mine was approved vide letter no DRG/LST/MPLN-231/NGP dated 13/10/2010 ,but you have not submitted the same to Regional Controller of Mines Indian Bureau Of Mines Nagpur Region for approval. The Non submission of the same attract the violation of rule 13(1) of MCDR 88 and may lead to suspension of mining operation under rule 13(2) of MCDR88.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 58 of MCDR'88.
- 03. You are therefore directed to show cause within a period of 30 (thirty) days from the date of issue of this letter, as to why mining operations in the mine should not be suspended in accordance to rule 13(2) for violation of rule 13(1) of the MCDR'88.
