Subject : Violation of provisions of Mineral Conservation and Development (Amendment) Rules, 1988 in respect of your **Zutting Limestone Mine** over an area of 58.25 Hect. in Chandrapur district of Maharashtra State.

Sir,

On examination of this office records and as per the inspection of your mines by the undersigned on 30/10/2013, the following provisions of Mineral Conservation and Development (Amendment) Rules, 1988 amended vide notification of GSR 75(E) dated 09.02.2011 are violated in respect of your above referred mine.

Rule	Nature of violations observed
45(5)	The owner, agent, mining engineer or manager of every mine, shall submit to the Regional Controller of Mines in the Indian Bureau of Mines or any other authorized official of the Indian Bureau of Mines, returns in respect of each mine, in the following manner, namely:- a) a monthly return which shall be submitted before the 10th of every month in respect of preceding month in the Form as indicated below:- (viii) for Limestone in Form F-8; (b) an annual return which shall be submitted before the 1 st July each year for the preceding financial year in the form as indicated below:- (viii) for Limestone in Form H-8;
45(7)	If it is found that the owner, agent, mining engineer or manager of the mine has submitted incomplete or wrong or false information in the monthly or special or annual return or fails to submit a return within the date specified, then the Regional Controller of Mines may,- a) order suspension of all mining operations in the mine and may revoke the order of suspension only after ensuring proper compliance; b) take action to initiate prosecution under these rules; c) recommend termination of the mining lease in case such suppression or misrepresentation of information indicates abetment or connivance of illegal mining However you have not submitted any return i.e. monthly return from March 2008 in Form F-8 onwards and annual return from 2007-08 to 2012-13 in Form H-8.
47	<p align="center"><i>Thus, you have violated rule 45(5) & 45(7) of Mineral Conservation and Development (Amendment) Rules, 1988. These violations lead to suspension of all mining operations in the mine as well as termination of mining lease and prosecution of the owner, agent and manager.</i></p> The owner, agent, mining engineer, geologist or manager of every mine or the holder of a prospecting licensee shall send intimation in Form J to the Controller General, Controller

of Mines and the Regional Controller within fifteen days after the commencement of any of the following operations:
(a) the sinking of trial shaft or borehole to a depth exceeding ten meters from the surface, or
(b) the extension of an existing shaft or borehole to a depth exceeding ten meters, or
(c) the sinking of a new shaft or boreholes commencing from underground workings:
Provided that the Controller General or the authorized officer may permit such intimation to be given collectively within such extended period as may be specified by him.
During last scheme period valid up to 31/3/2015 you have drilled eleven bore holes as reported in the draft modified mining scheme but notice as required under above rule has not submitted.

02. In this connection, it is brought to your notice that, the above violation of said rule constitutes an offence punishable under Rule 58 of MCDR, 1988.

03. You are, therefore, **directed to show-cause within a period of 30 days** from the date of issue of this letter, as to why mining operations in your above mine should not be suspended in accordance to rule 45(7) of MCDR, 1988.

04. Please note that no further notice will be given to you in this regard.
