Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Pidugurla Limestone Mine of Smt Swarna Akkamma, over an extent of 74.78 Ha. situated in Pidugurla village & Mandal, in Guntur district of Andhra Pradesh state.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017, were found violated in your above mine based on scrutiny of office records of this office and during the inspection of the mine on 19.06.2018 by the undersigned accompanied by Shri S Subramanyam your son.

- 02. It is noted that the Monthly & Annual returns have not been submitted timely for the month of May 2018 & for the year 2017-18, even through online, which is a statutory return and is being used by the Government for various purposes. Any delay in it causes incorrect representation of various data having financial implications.
- 03. In this connection, it is brought to your notice that continuing contraventions of the provision of these rules by submitting late returns also attracts the action as per the provision of rule 62 of MCDR, 2017.
- 04. Inability to comply the provision of rules 45 (5) of MCDR, 2017 and submitting incomplete or wrong or false information in the monthly or annual returns is also liable for suspension of Mining operations and other actions as per the provision of rule 45(7)(a) of MCDR 2017. Any delay in submission of returns may be construed as suppression of information requiring timely disclosure and may be recommended for termination of lease also.
- 05. You are therefore advised to rectify the above violation immediately for compliance with the provision of rules by timely submission of returns and further intimate the position of compliance to this office within 45 (forty-five) days from the date of issue of this letter.
