Subject: Violation of provisions of MCDR 2017 in respect of Vyasanakere Iron Ore Mine (M.L. No. 2416) of M/s MSPL Ltd, over an extent of 347.22 ha, in Vyasanakere Village, Sandur Taluk, Bellary district, Karnataka State...Reg.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017 were found violated in your above mine during the inspection on 9/9/2017 by undersigned in the presence of Mines Manager S/Shri Domnic Savio & Shivkumar, Geologist.

Rule 11(1)	It was proposed in Review & Updation of Mining Plan approved vide letter No. 279/143/90/BNG/1772 dated 04/07/11.2016 for the period 2017-18 to 2021-22.. The deviations observed in mining operations vis-a-vis approved document are given below: (i). The proposed development & production as per the year 2017-18, given in plate No. VIII/A/1, and the field observation made on the day of inspection found not adhere to the plan & section given.
Rule 45(7)	Annual return, for the year 2016-17, In Part-I, Sl.no. 12(iii), wherein 130.054 ha area has been marked for reclamation & rehabilitation is not appropriate & correct. If it is so, why this is not updated in the surface plan. This need to be reconciled and corrected.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.

03. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
