

Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Bhimgoda Limestone Mine, Mining Lease over an area of 3.32 ha located near Village-Kamroo.

Tehsil-Paonta Sahib in Sirmour district of Himachal Pradesh State-Reg.

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the inspection made by the undersigned on 23.01.2020 in the presence of Shri Som Prakash Tomar, Mine Manager and the same was communicated to you vide our letter of even number dated

on 31-03-202	NATURE OF VIOLATION OBSERVED
RULE NO.	Mining operation were not carried out in accordance with the approved modified mining plan vide letter no 614(2)/MP-B-288/08- DDN dated 22.02.2019 to the following extent:  As per proposal during the year 2019-20, it was proposed to carry out mining operation from 2045 to 1985 mRL by formation of benches 6 mtr height. During the inspection height of benches has been observed up to 10 mtrs whereas as per approved modified mining plan it should be six meter.
29	"Mine was found in operation, whereas Intimation of re-opening of mine through Form-C has not been submitted to the authorized officer in the prescribed form on resumption/ re- start of mining operation after temporary discontinuance, so as to reach this office within 15 days from the date of such
55	Every holder of mining lease shall employ a geologist in the mine. But geologist has not been appointed in the mine.

In connection to above you have not submitted the compliance of violated rules, thus it has been considered that you do not intend to comply the violated rules and the violation of Rules 11(1), 29 & 55 of MCDR, 2017 still 3. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under

Rule 62 of MCDR 2017.

Mining Operation can be suspended as per rule 11(2) in case of non compliance of rule 11(1) of MCDR 2017.

5. May initiate appropriate action in accordance with any competent orders/directives etc.

6 You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted and / or why mining operation can be suspended under statutory provisions.

Please note that no further notice will be given to you in this regard.
