Violation of provision of MCDR, 1988 in respect of Limestone Quarry No. III of M/s Panyam Cement & Mineral Industries, Ramatheertham (Kandikayapalli), mine over an area of 17.69 ha in Sy.No. 631(P) & 738 of Alamuru Village, Panyam Mandal, Kurnool District, A.P. State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in the above mine during the inspection on 25.7.2016 by the undersigned of this office in the presence of official Sri C Sreenivasa Reddy, Mine Manager.

| 13(1)          | <ul> <li>(i) Mining operations should have been undertaken in accordance with the approved Mining Plan/Scheme of Mining. Since you have no approved Scheme of Mining for your above mentioned Mine, it is evident that the mining operations are not being carried out in accordance with the approved Scheme of Mining.</li> <li>(ii) There was proposal for backfilling in western side of the lease against which part backfilling has been done.</li> <li>(iii) Mining operations have been carried out in 7.5m safety barrier zone without any proposal in approved document.</li> </ul> |
| 45(5)(b)(viii) | Annual returns in Form H-8, for the year 2015-2016 has not been submitted to the  |

- 02. In this connection, it is brought to your notice that non compliance of violation of Rule 13(1)( and 45(5)(b)(i) attract the provisions of Rule 13(2) and 45(7)(i)(a) of MCDR, 1988.
- 03. You are, therefore, directed to show cause within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence or mining operations suspended under Rule 13(2) & 45(7)(1)(a) of MCDR, 1988.
- 04. Please note that no further notice will be given to you in this regard.
