**Sub:** Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of Pandarettu Limestone mine over an area of 234.94 ha situated in Pudussery East and Malapuzha-I villages, Palakkad taluk & district, Kerala state. .

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in above mine during the inspection on 05.12.2017 by Sri K. Srinivas. Asstt. Mining Geologist and communicated to you vide this office registered letter of even no. dated 26/12/2017 giving you a period of 45 (Forty Five) days' time for rectification of the same.

Rule No.	Violations observed
11(1)	Scheme of mining was approved vide letter no. 279/464/95/BNG dated 10.3.2016
	for the period 2016-17 to 2020-21. The deviations observed in mining operations vis-
	à-vis the approved document are given below.
	Every holder of mining lease shall carry out mining operations in accordance with
	the approved mining plan/scheme of mining. The mining operations are not being carried out in accordance with the approved scheme of mining.
	(i) As per the approved document, the drilling of two exploratory core
	boreholes has been proposed during the year 2016-17. The same has not been carried out.
	(ii) The construction of retaining wall of 800m length and garland drain of 810m
	along toe of the dump has been proposed during the year 2016-17. The same has not been carried out as proposed in the approved document.
27(2)	As per the rule, the holder of mining lease is required to submit the Financial
27(2)	Assurance in the form of bank guarantee for the balance amount which is equal to
	the difference between the FA due as on the date of notification of these rules and
	the FA already furnished. The same has not been submitted.
55(1)	As per the rule, every holder of mining lease shall employ a whole-time mining
	engineer and a geologist, but no such appointment of Geologist has been made in the
	mine as observed during the field visit.

- **02.** No reply in this regard is received in this office till date for rectification of the above violation. The lessee has not complied the violation so for.
- **03.** It is again brought to your notice that these violations constitute an offence punishable under rule 62 of MCDR 2017. On non compliance of the above provisions of MCDR 2017, the mining operation can be suspended under the rule 11(2) of the above mentioned rules.
- **04.** You are therefore, directed to show cause within a period of 30 (thirty) days from the date of issue of this letter as to why you should not be prosecuted for the above offence.
- **05.** Please note that no further notice will be given to you in this regard.
