Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Gudeghar Bauxite Mine, (Mine Code 07MSH20006, area 91.58 Ha) M/s Infrastructure Logistics Pvt. Ltd situated in Gudeghar Village of Mandangad taluka, Ratnagiri District of Maharashtra.

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 13/05/2019 by the undersigned in presence of Mr. Pramod Sarode, Mines Manager and Mining Engineer.

Rule	Nature of Violation observed
Rule 11(1)	Mining Operation have not been carried out in accordance with the Scheme of Mining(SOM) approved vide letter no. MSH/Mech-75(MAH)/Goa/2014-15, dated 18.02.2015 to the extent indicated below:- (i) Exploration was proposed to be carried out from 2015-16 to 2017-18 by drilling 40 core boreholes at earmarked place to cover the entire lease area. Although some boreholes were reported carried out and further the explorataory drilling machine was also observed in place. However, the aforesaid proposal were not completed in the earmarked places as approved in SOM. (ii) The excavation was proposed to be carried out between the section lines 300650 to 300750 in the year 2018-19. However, it has observed during the inspection that excavation was carried out between the sectional grid lines 300500 to 300600. (iii) Large quantity of mineral stacks were observed without safeguarding the substantial environmental protective measures to control from the washoff of material.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
