45(7)	If it is found that the Owner, Agent, Mining Engineer or Manager of the mine has submitted incomplete or wrong or false information in monthly or annual return or fails to submit a return within the date specified then the Regional Controller of mines may: (d) order of suspension of all mining operation in the mine, (e) take action to initiate prosecution under these rules; (f) recommend termination of mining lease. However, it is observed that you have not submitted annual returns and Monthly Returns for more than four years. Thus you have failed to submit returns within the date specified and violated the provision of rule 45(5) and 45(7) of Mineral Conservation & Development Rules 1988, which may lead to suspension of mining operation in the mine as well as prosecution of owner, agent, mining engineer or manager and recommendation for termination of lease.
24	Your mine is found to be closed more than Ninety days. The notice in Form D-1 on intimation of temporary discontinuance of work is not submitted to Controller General, Controller of Mines and the Regional Controller of Mines.
