- 1) Cover page: i. 'C block' should be deleted.
ii. Two months of year 2018-19 has been lapsed. So Proposal should be given for June, 2018- 2019.
- 2) Introductory note: i. Lease period has extended up to 50 years. Information related to this has not been given.
ii. Description describing to topography given on page number 11 is not reflecting true position of area. Lease areas is comprising of detached blocks but it has not been described *satisfactory. correctedly.*
- 3) Para 1.a: Information related to phone & fax number has not been given.
- 4) Para 2.a: i. Only Lat/long has given. Related pillar number has not been indicated.
ii. Date of deed execution and lease period has not been given.
iii. Phone & fax No has not been given.
- 5) Para 2.b: Pillar No 41 to 80 has left.
- 6) Point 2.c related to location map has not attended.
- 7) Para 3.3: i. Actual production for year 2017-18 has not been given.
ii. Review for lapsed period (April - May, 2018) should be given.
- 8) Review has not been properly drafted. Details of violation pointed out have not been properly discussed on page No 10.

- 9) Para 1.f, g, h: Plate number of surface plan, geological plan & sections should be given.
- 10) Para 1.i: Mine plan has been prepared for one year only. Reserves will be exhausted in this time. So to confirm the continuity of chemical grade limestone it is necessary to incorporate the prospecting proposal at pit bottom as per rule 12 of MCDR, 2017. As exploration work is not adequate to ascertain the potentiality of the area. *Area*
- 11) Para 2.A.a: Mining method has not been proposed.
- 12) Para 2.A.b: i. Production proposal should be given for June, 2018-19.
ii. Top soil is available in the area. Please calculate it.
iii. Percentage of mineral rejects has not been given.
iv. Bulk density & recovery factor has not been given.
- 13) Point 2.A.c, d & e related to individual year wise development plan, salient feature of proposed method of working & lay out of mine workings etc has not been attended.
- 14) Para 8.2.v: Points related to vibration level (due to blasting), water regime, acid mine drainage, surface subsidence, socio-economics & historical monuments have not been attended.
