Sub: Violation of provisions of MCDR, 1988 in respect of Sahegaon Limestone mine over an area of 4.82 ha in Sahgaon village, Tah.-Dhamda, District-Durg, Chhattisgarh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection on 22.11.2016 by Shri Anil Dalal, AME, IBM in the presence of your representative Srimukh.

Rule No.	Nature of Violation
45(5)	The owner, Agent, Mining Engineer or Manager of every mine shall submit to the Regional controller of mines in the Indian Bureau of Mines or any other authorized official of the Indian Bureau of Mines, returns in respect of of each mine, in the following manner, namely:- (a) A monthly return which shall be submitted before 1 st July each year in respect of preceding month in the form as indicated below:- (b) (vii) for other minerals in Form F-8
45(7)	If it is found that the Owner, Agent, Mining Engineer or Manager of the mine has submitted incomplete or wrong or false information in monthly or annual return or fails to submit a return within the date specified then the Regional Controller of mines may:- (a) order of suspension of all mining operation in the mine, (b) take action to initiate prosecution under these rules; (c) recommend termination of mining lease. However, it is observed that you have not submitted annual returns for the year 2014-15 and 2015-16 till date. You have also not submitted the Monthly Return from the month April 2014 onwards. Thus you have failed to submit returns within the date specified and violated the provision of rule 45(5) and 45(7) of Mineral Conservation & Development Rules 1988, which may lead to suspension of mining operation in the mine as well as prosecution of owner, agent, mining engineer or manager and recommendation for termination of lease.
46	Intimation of appointment of part time mining engineer under sub-rule (6) of rule 42 is not submitted in Form I to the Controller General , Controller of Mines and the Regional Controller of Mines.
