Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Curpem iron Ore Mine, Cantor mining Lease( TC.No.3/1951 ), M/s Sesa Resourses Ltd. situated in sanguem-Taluka, South Goa- District of Goa State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 03/06/2017 by the undersigned in presence of Mr. Prakash Chandra, Manager mines & Mining Engineer, Mr. A.K. Dash, Geologist and other Officers.

Rule	Nature of Violation observed
37(1), 37(2) & 37(6)	Every holder of a prospecting licence or mining lease shall take steps so that overburden, waste rock,rejects and fines generated during prospecting or mining operations shall be deposited and disposed in such they are not allowd to flow away and cause land degradation or pollution of surface water bodies and ground water.
	(i) Whereas It was observed during the inspection that the drainage channel passing through the toe of the overburden dump without securing retaining wall. This may result in escape of wash-off material therefrom in harmful quantities which may cause the degradation of environment.
	(ii) It was also observed that the substantial quantity of wash-off material accumulated at the pit bottom which may pollute the water bodies and cause degradation of environment.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
