Sub :Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Hebbal Limetone and Dolomite Mine, Area-4.856 Ha, (M.L.No.2656), situated Bagalkot-District of Karnataka State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 8/03/2018 by the undersigned in presence of Mr. Suresh B.Katti,Lessees Son.

Rule	Nature of Violation observed
26(2)	An yearly report on progressive Mine closure Plan before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive Mine closure plan has not been submitted for the year 2016-17.
11(2) & 27(2)	As a financial assurance of an amount equal to the difference between the financial assurance due as on the date of notification of MCDR,2017 and the financial assurance already furnished,shall be furnished to the authorized officer within a period of ninety days from the date of notification of these rule. However, the same has not been furnished to the competent authority and thusprovisions of rule 11(2) regarding suspension of mining operations can be invoked.
55(3)(iv)	The Mining Engineer and Geologist required under these rule are not appointed.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
