Sub :Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Muddapur Limestone Mine, (M.L.No.2672), Shri V.R.Mathad situated in Muddapur Village, Mudhol Taluka,Bagalkot- District of Karnataka State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 06/03/2018 by the undersigned in presence of Mr. Govinda shetty, Mines Manager.

Rule	Nature of Violation observed
11(1)	Mining operations have not been carried out in accordance with the modification of Mining Plan approved vide MP/MAN-613(KNT)/GOA//207-08 dated 30/08/2011. As per the aforesaid approved MMP the height of benches were proposed upto3m. Whereas, It was observed during the inspection that the height of benches were between 5m to 6m,which is against the safety of the persons deployed and requirement of the scientific mining.
11(2)&27(2)	A financial assurance of an amount equal to the difference between the financial assurance due as on the date of notification of these rules and the financial assurance already furnished,shall be furnished to the authorized officer within a period of ninety days from the date of notification of these rule. However, the same has not been furnished to the competent authority under these rule.This may attract the provisions of rule 11(2) for suspension of mining operations.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
