Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Manoli (Vhatkar Mines), lease area-143.95Ha of Shri V.K.Vhatkar, situated in Kolhapur District, Maharshtra State

Sir.

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 13/03/2018 by the undersigned in presence of Mr.Niraj Jaju,Agent,Mr.Pravin Likhar, Mines Manager.

Rule	Nature of Violation observed
11(1) & 26(2)	An yearly report on progressive Mine closure Plan before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive Mine closure plan has not been submitted for the year 2016-17. This was one of the condition of Scheme of Mining approved by this office vide dated 01/06/2015
45(7)	In Annual Returns, submitted from your mine for the Financial, Year 1 st April 2015 to 31 st March 2016 and 1 st April 2016 to 31 st March 2017; it was observed that the production figures as furnished in Part VI, Para 1 . (Production and stocks of ROM ore at Mine head) and Para 2 . (Grade-wise production,Despatches,Stocks and Ex-Mine price of processed/sorted ore) were shown different and hence not matching to balance the transactions. Also, it was observed that, the furnished ex-mine price is not supported with the cost of production and sale value of mineral. The above figures are unrealistic, incomplete or false as submitted by you.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
