Sub: Violation of provisions of MCDR, 2017 in respect of Pedaveedu Limestone Mine over an area of 326.58 ha in Pedaveedu Village, Suryapet District, Telangana State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 09.07.2021 by the undersigned accompanied by Sri V.Subramanyam, Mines Manager.

Rule No.	Nature of Violation
31(1)	Every plan or section prepared or submitted in accordance with the provisions of the MCDR,2017.
	"In the surface Plan all the features have not been marked. An updated Surface Plan to be submitted."
45(7)(a)	The holder of a mining lease shall submit online returns in respect of each mine to the Regional Controller or any other authorised official of the Indian Bureau of Mines in the following manner, namely an annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same if it is not digitally signed, in the respective Form. "Calculation of cost per tonne for different heads are not in congruence with values submitted in other modules".

- 02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-62 of MCDR, 2017. Further, inability to comply the provision of Rule 45(7)(a) is liable for suspension of mining operations under 45(7)(a) of MCDR,2017.
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
