The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on13/02/2018(A/N), by the undersigned in presence of Shri Shankaraiah, Mine mate.

26(2)	An yearly report before 1st July of every year setting forth the extent of
	protective and rehabilitation work carried out as envisaged in the approved
	progressive mine closure plan has not been submitted for the year 2016-17 so far.
27(1) & 27(2)	The differential financial assurance for the mining and allied activities as per
	MCDR 2017 is not paid for the entire area as shown in the PMCP chapter of
	approved Modified mining plan within 90 days from the commencement of
	MCDR 2017.

31(4)	The plans and section required under the MCDR rules 2017 are not updated
45(5)(C)	Annual return for the year 2015-16 is not submitted to this office so far.
Rule 48	Details of drilled boreholes are not recorded in the form-I.
55(1)(3)(iii)	The Mining Engineer and Geologist required under the said rule is not appointed by the lessee.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
