Sub :Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Timmapur Limestone and Dolomite Mine(M.L.No-2272/2481) over an extent of 15.641 Ha. Situated in Timmapurvillage, Tq- Mudhol, in Bagalkot District of Karnataka State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on12/02/2018(A/N), by the undersigned in presence of Shri K.Shivaram, Mines Manager.

Rule	Nature of Violation observed
11(1)	a) In the approved Modified Mining plan dated 1/2/2017, there was a proposal to drill 10 core boreholes to a depth of 40mtr/each, in the year 2017-18. During inspection it was observed that only five boreholes were drilled and drilling machine was shifted without completing proposed exploration. b) In the approved document waste dump was proposed between in the south –westren part of the lease area near section A-A'. However during inspection it was observed that dumping was made in the South eastern part of the lease area and some quantity was dumped outside the lease area.
27(1) & 27(2)	The differential financial assurance for the mining and allied activities as per MCDR 2017 is not paid for the entire area as shown in the PMCP chapter of approved Modified mining plan within 90 days from the commencement of MCDR 2017.
31(4)	The plans and section required under the MCDR rules 2017 are not updated
Rule 47	Notice of sinking boresholes in the form-I is not sent to this office so far.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

**03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.**

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
