Sub :Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Gudeghar Bauxite Mine, over an extent of 91.58 Ha. Situated in Gudeghar village, Tq-Mandangad, in Ratnagiri District of Maharashtra State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 22/12/2017 by the undersigned in presence of Mr.Pramod Sarode Mines Manager.

Rule	Nature of Violation observed
26(2)	An yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted for the year 2016-17 so far.
Rule 45	In the annual returns submitted for the year 2016-17, closing stocks are not matching with the opening stock, production and dispatch figures.
67	A self appraisal note to be submitted by the mines owner/lessee stating extent of implementation of approved minig plan/scheme of mining during the year 2016-17 along with supporting plan & sections ,representative photographs is not submitted to this office so far in hard as well as soft copy.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
