Sub :Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Girgaon-Ringewadi Bauxite Mine, over an extent of 576.12 Ha. Situated in Burambal,Panundre villages, Tq- Shahuwadi, in Kolhapur District of Maharashtra State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 20/09/2017 by the undersigned in presence of Mr.A Gururaj Mines Manager.

Rule	Nature of Violation observed
11(1)	a) In the approved modified mining plan dated 28/07/2016 there was a proposal for 20 trial pits with dimesion of 2m x 2m x 4m. During inspection it was observed that no such pitting was done by the lessee. b) In the year 2016-17 there was a proposal for working and backfilling the float ore between the co-ordinates N-1861180 to N-1861480 and E-3829970 to E-383220. During inspection it was observed that working has been not carriedout as per the proposal.
26(2)	An yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted for the year 2016-17 so far.
Rule 45	In the annual returns submitted for the year 2916-17, following deficiencies were observed. I)The lease area is not properly mentioned. ii) Details of OB handled and area backfiled are not mentioned. iii) Mineral reject is shown as 1350 tonnes whereas there is no mineral reject generated in the said year.
46(b)	Notice of termination of Shri Pravin Vasanttrao Likhari Mining engineer and Shri Amar Ramchandra Rane geologist is not submitted to this office so far.
55(3)(iii)(iv)	The Mining engineer and Geologist required under the said rule are not appointed by the lessee.

67	A self appraisal note to be submitted by the mines owner/lessee stating extent of implementation of approved minig plan/scheme of mining during the year 2016-17 along with supporting plan & sections ,representative photographs is not submitted to this office so far in hard as well as soft copy.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
