Sub :Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Suctoli (Saile tembo) Mine (T.C.No-143/53) over an extent of 99.0305 Ha in South Goa District.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 08/08/2017 by the undersigned in presence of Mr.Momin Naushad Ahmed Mines Manager and Mr.Sudhir Kumar Mining Engineer.

Rule	Nature of Violation observed
11(1)	In the approved modified mining plan dated 07.03.2017 there was a proposal for backfill (temprry) between N-141 to N386 & E-165 to E-370 from 80m level to 90m level. However during field visit it is observed that temprry backfilling was made between N-200 to N-400 and E-200 to E-330 and backfilling was made upto 95m.
26(2)	An yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted for the year 2016-17 so far.
37	The ore and waste generated during mining operations should store separately. However during field visit it is observed that ore is stacked on the waste dump at dump no-2.
46	Notice of appointment of Shri Sudhir Kumar as Mining Engineer is not sent to this office so far.
67	A self appraisal note to be submitted by the mines owner/lessee stating extent of implementation of approved minig plan/scheme of mining during the year 2016-17 along with supporting plan & sections ,representative photographs is not submitted to this office so far in hard as well as soft copy.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
