Sub :Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Kalay Mine (T.C.No-06/55 & 12/52) over an extent of 101.7130Ha & 77.4696 Ha in South Goa District.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 09/08/2017 by the undersigned in presence of Sanjay Kumar, Mining Engineer.

Rule	Nature of Violation observed
11(1)	a) In the approved modified mining plans dated 31.08.2016 there was a proposal to drill 35 boreholes to a depth of 2100 mtrs in the lease area bearing T.C.No-40/51. During field visit it was observed that no such exploration work has been carried out by the lessee. b) The backfilling in the T.C.No's 12/52 and 40/51 is not made as per the proposal shown on Production & developments plans submitted for the year 2016-17 and 2017-18. c) In the T.C.No-40/51 there was a proposal to construct rubble wall of length 260m x 1.5m x 1.5m in the year 2016-17 at the toe of waste dump. However no such construction was observed during inspection.
26(2)	An yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted for the year 2016-17 so far.
67	A self appraisal note to be submitted by the mines owner/lessee stating extent of implementation of approved minig plan/scheme of mining during the year 2016-17 along with supporting plan & sections ,representative photographs is not submitted to this office so far in hard as well as soft copy.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

**03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.**

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
