Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Nagnapur Limestone Mine (M.L.No-2357) over an extent of 4.43 Ha. Situated in Nagnapur village, Tq- Mudhol, in Bagalkot District of Karnataka State. Sir,

Undersigned inspected your above mine on 16.02.2018 in presence of the mine officials Shri Suresh Mathad Lessee's son and violation letter of even number dated 01.03.2018 was issued for below mentioned rules of Mineral Conservation & Development Rules, 2017.

Rule	Nature of Violation observed
11(1)	The following deviations were observed in the approved Modified Mining Plan dated 27.12.2016.  a) The working is not carriedout as per the proposal mentioned on the production and development plan for the year 2017-18.  b) waste dumping was not made as per the proposal.
27(1) & 27(2)	The differential financial assurance for the mining and allied activities as per MCDR 2017 is not paid for the entire area as shown in the PMCP chapter of approved Modified mining plan within 90 days from the commencement of MCDR 2017.
31(4)	The plans and section required under the MCDR rules 2017 are not updated
55(1)(3)(iii)	The Mining Engineer and Geologist required under the said rule is not appointed by the lessee.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.
- 05. Please note that no further notice will be give to you in this regard.
