Sir.

The following provisions of Mineral Conservation and Development Rules 1988, were found violated in your above mine during the inspection on 09/04/2014 by Sri.N.Subrahmanyam Assistant Mining Engineer of Indian Bureau of Mines, Chennai.

RULE No	NATURE OF VIOLATION
13(1)	Mining operations are being carried out in violation of the following provisions of approved scheme of mining.
	The production is in excess of the approved proposals in the scheme of mining. During the year 2011-12 of scheme of mining, it was proposed to produce 122 tones of Quartz and 489 tonnes of Feldspar. But, in actual, the lessee had produced 4160.900 tonnes of Quartz and Feldspar.
42(1)(c)(ii)	No part-time mining engineer and a part-time geologist employed.
45(5)(a)	The Owner, Agent, Mining Engineer or Manager of every mine shall submit monthly return of the mine before 10 th of every month in respect of preceding month in the form F-8. But the party has not submitted the same to the Regional Controller of Mines, Indian Bureau of Mines, Chennai, since January 2014.
45(5)(b)	The Owner, Agent, Mining Engineer or Manager of every mine should submit an annual return of the mine before the 1 st July every year for the preceding financial year in form H-8. But the party has not submitted the same to the Regional Controller of Mines, Indian Bureau of Mines, Chennai for the year 2010-11 and 2012-13.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of Mineral Conservation and Development Rules 1988.
- 03. You are advised to rectify the above said violation immediately and intimate the position to the office within 45(fourty five) days from the date of issue of this letter.
