- 1) Scientific mining

i) Exploration: No exploration proposal during 2012-13 and 10 numbers of boreholes with 400 total meterage were proposed during year 2013-14. However, no exploration was carried out till the time of inspection (i.e. upto Nov 13).

ii) Workings: During inspection, it was observed that there is only one existing pit and dimension of which is 560 m X 260 m X 75m. The pit was found systemically developed.

The regular dust suppression by sprinkling of water is made in the mine, colony and plant areas. The season-wise environmental monitoring of air, water and noise have been made in their own laboratory and the various parameters are found within the permissible limit. The lessee had constructed 250 m long parapet wall at bottom of waste dump as proposed.
