Sub : Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of your KUMBHASHI Silica sand mine (ML. No 2485) in Udupi Dist of Karnataka State.

Sir,

The following provisions of Mineral Conservation & Development Rules, 1988 was found violated during inspection your above mine on 8/12/2013 by **special Task Force – III(Phase-II)Year-2013-14** consisting of S/Shri A.Nandi, DCOM & Team Leader, Prashant S. Hegde, SMG & member alongwith Shri Niranjana A.M., Sr. Geologist, State DMG, in presence of Shri Shivananda Surathkal, General Power of Attorney.

Rule No.	Nature of violation observed
45(5)(b)(viii)	The Annual Return for year 2012-13 has not been submitted in form-H-8 on or before 1 st July of 2013.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988. The relevant extract of the rule 58 is given below:

“58 Penalty: - Whoever contravenes any of the provisions of these rule shall be punishable with imprisonment for a term which may extend up to two years, or with fine extending to fifty thousand rupees or with both, and in the case of continuing contravention with an additional fine which may extend up to five thousand rupees for every day during which such contravention continues, after conviction for the first such contravention.”

03. You are therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why you should not be prosecuted for the above said offence and / or why the mining operation in the mine should not be suspended under rule 45(7)(i)(a) of MCDR 1988 for non-compliance of rule 45(5)(b)(viii) of MCDR 1988.
