Sub: Violation of provisions of MCDR, 1988 in respect of Miragpur Manganese Ore Mine (Area 24.288 ha)

Sir

The following provisions of Mineral Conservation & Development Rules, 1988 are found violated in your above mine during inspection on 24/09/2013 by ShriHarkeshMeena, Deputy Controller of Mines, Jabalpur (Team Leader) and **Dr. A. K. Ghoshal**, Junior Mining Geologist, Nagpur Regional Office, accompanied by Shri R. P. Kamlesh, Assistant Mining Officer, A. K. Nagle, Mining Inspector and M. A. Quereshi, Mining Surveyor, DGM, Balaghat, Govt. of M.P. and ShriAbhishekRai, Representative of the lessee and V. L. Kalambe, Mines Manager of your mine.

Rule No.	Nature of Violation
13(1)	<p>Every holder of a mining lease shall carryout mining operations in accordance with the approved mining plan / scheme of mining with such conditions as may have been prescribed under Sub Rule (2) of Rule 9 or such modifications if any, as permitted under Rule 10 or the mining plan or scheme of mining approved under Rule 11 or 12 as the case may be.</p> <p>It was observed that the mining plan was approved vide letter No. BGT/MN/MPLN-907/NGP, dated 30.11.2005, The mining plan was valid up to 31.01.2013. The scheme of mining for the next five-year period was due for submission on 30.09.2012. The same has not been submitted so far.The mining operations are being continued without valid scheme of mining, thus attracting the violation of Rule 13(1) of MCDR 1988, which may lead to suspension of mining operations in accordance to the Rule 13(2) of the MCDR 1988.</p>
23F (3)	<p>The financial assurance has to be furnished by every lease holder. The amount of financial assurance shall be Rs. 25,000/- for ‘A’ category mines and Rs. 15,000/- for ‘B’ category mines per hectare of the mining lease area put to use for mining and allied activities. However, the minimum amount of financial assurance to be furnished in any of the forms referred to in clause 2 of Rule 23F shall be Rs. 2 lacs for ‘A’ category mines and Rs.1 lac for ‘B’ category mine. But it was observed that no financial assurance has been submitted to the Regional Controller of Mines, Nagpur for lease area under reference.</p>
45(5)(a) & 45(5)(b)	<p>The owner or agent or mining engineer or manager of every mine, shall submit to the RCOM, IBM or any other authorised officials of IBM, returns in respect of each mine, in the following manner namely,</p> <p>a) Monthly return, which shall be submitted before 10th of every month in respect of preceeding month in the form as indicated below: (ii) for manganese ore in Form F-2.</p> <p>(b) an annual return which shall be submitted before first July of each year for the preceeding year in the form as indicated below: (ii) for manganese ore in Form H-2.</p> <p>It was observed that the monthly return from July, 2013 and annual return for the year 2012-13 have not been submitted to this office.</p>

- 03 It is brought to your notice that the above violations constitute an offence punishable under rule 58 of MCDR, 1988.
04. You are therefore directed to **SHOW CAUSE** within a period of 30 days from the date of issue of this letter, as to why mining operations in your mine should not be suspended under rule 13(2) for the violation of provision of rule 13(1) as above.
