
Sir,

This has reference to the letter cited above on the subject. The draft of Modification of approved Mining Plan along with Progressive Mine Closure Plan (PMCP) has been examined in this office based on earlier site inspection carried out by Shri N M Dey, Assistant Mining Engineer on 26.06.2015. The deficiencies observed are enclosed herewith as Annexure I.

You are advised to carry out the necessary modifications in the draft Modification of approved Mining Plan along with Progressive Mine Closure Plan in the light of the contents vide Annexure I and submit **three (3) firm bound and two (2) soft copies of the document text in CD in a single MS Word file (the drawing/plates in Auto CAD compatible format or JPG format in resolution of 100x100 pixels on same CD )** with financial assurance under Rule 23 F of MCDR 1988 of the Modification of approved Mining Plan within 15 (fifteen) days from the date of issue of this letter, for further necessary action. If the total page of annexures exceeds 50 (Fifty) then it should be submitted as separate volume. But reference of these annexures must appear in the Modification of approved Mining Plan document. The plates are also to be submitted in separate volume.

The para-wise clarifications and the manner in which the deficiencies are attended should invariably be given while forwarding the modified copies of the Modification of approved Mining Plan along with Progressive Mine Closure Plan. It may be noted that no extension of time in this regard will be entertained and the Modification of approved Mining Plan along with Progressive Mine Closure Plan will be considered for rejection if not submitted within above due date. It may also be noted that if the deficiencies are not attended completely, the submission would be liable for rejection without further correspondence.

**Scrutiny comments in respect of Modification and Review of Mining Plan including Progressive Mine Closure Plan (PMCP) of Putka Limestone Mine over an area 97.031 ha in Bargarh district of Odisha state, submitted by Shri Jyoti Pramanik under Rule 17 of MCR, 2016 for the period 2016-17 to 2020-21.**

### **INTRODUCTION:**

1. At page no.2 it is mentioned Putka Mining lease area over 240.674 ha needs correction as 97.031 ha.
2. At page no.2 it is mentioned Mineable reserve as on date is 14,39,609 t, needs correction. Instead of as on date it should be mentioned as 01.04.2005.

### **1.0 GENERAL**

(a) Registration number of the Mine Owner IBM/19790/2015, allotted by IBM, Nagpur on 02.08.2016 under Rule 45 of MCDR (Amendment) Rules, 2011 has not been mentioned. The same should be mentioned. Fax and E-mail id of the lessee has not been mentioned.

### **2.0 LOCATION AND ACCESSIBILITY**

1. Surface plan has not been signed and certified to be correct by a statutory / registered / certified Surveyor with date and certificate number.

### **3.0 DETAILS OF APPROVED MP / SOM (if any)**

Initial grant of Mining Lease period was for 20 years from 25.09.1974 over an area 240.674 ha. First renewal of mining lease was over an reduced area 97.031 ha with effect from 25.09.1994 for a period of 20 years upto 24.09.2014.. Application for subsequent renewal of mining lease filed on 21.09.2013 Available mining plan approved on 16.11.2005 submitted under rule 24 A of MCR, 1960 was for the period 2005-06 to 2009-10. Subsequent Scheme of Mining / excavation proposal for the period 2010-11 to 2015-16 has not been prepared. Reasons / justification have not been given.

### **3. MINE DRAINAGE**

1. Murmuri Nala on the north side of the lease which is also the state boundary is flowing very close to the lease boundary HFD. Necessary precautions should be taken to arrest solid wash off etc from the mine run off.
