The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection on 15.12.2016 by undersigned

in the presence of Shri Siddharth Verma & Shri Vikeshwar Thakur (Maneger Mines).	
Rule No.	Nature of Violation
42(1)(c)(ii)	For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules: "Every holder of a mining lease shall employ, in case of category 'B' mines, a part time mining engineer and a part time Geologist". However during the inspection it was observed that a part time Mining Engineer/ Geologist has not been employed under this rule.
45(7)	On examination of annual return submitted by you in respect of aforesaid mine, it is observed that in part VI, item 5, there is dispatch of limestone, however the name and registration no of the consignee's to whom the mineral is sold have not given in the return.

In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988. Besides, inability to comply the provision of Rules 13(1) & 45(7) are also liable for suspension of mining operations under the provision of Rule 13(2) & 45(7) of MCDR, 1988.

You are advised to rectify the above violations immediately and intimate the position to this

office within 45 (forty five) days from the date of issue of this letter.
