#### **PART – II – TECHNICAL DETAILS**

 Sensitive technical items on conservation of mineral, scientific mining and protection of environment – status of Present Mining Operations vis-à-vis approved proposals of mining plan / Scheme of Mining:----

#### 1) Scientific mining

<u>i) Exploration</u>: No exploration neither proposed nor carried out. The trend and occurrence of deposit could easily be assessed from exposure in the existing pit as there is no OB.

<u>ii) Workings</u>: During inspection, it was observed that the mining operations are being carried out with the approved document. Subsequent scheme of mining has not been submitted to the officer authorized by the State Government. Half of the lease area has been partly back filled with red soil. The dimensions of existing current pits are viz 1) 40m X 20 m X 2.5m and 2) 15mx 6m x 3m. Mining is being carried manually with pickaxes & crowbars. There is no OB and no drilling & blasting required.

There is no adverse impact on air, water and noise inside the ML area because mining is being carried out **on a small scale**. The excavated pit areas are backfilled by filling up with red-soil purchased by lessee.

II) A note on justification in case of suspension of mining operations under rule 13(2) or prohibition of deployment of any person under rule 56 of MCDR, 1988 if recommended:---

Mining Plan of the mine which was approved in January 2004 had expired but the subsequent Scheme of Mining has not been submitted under the rule to the officer authorized by the State Government at least One hundred twenty days (120) before the expiry of five years period for which it was approved on the last occasion but the mining operations are being carried out without approved document and it was also noticed that the excavation has been carried out in the safety barrier of 20m along Eastern boundary perimeter i.e Panchayat Road to Kalikulam Village.

The lessee has not submitted the financial assurance to the Regional Controller of Mines or the officer authorised by the State Government along with the progressive mine closure plan.

**III)** Any other matter of significance: No statutory personnel employed at the mine i.e Mines Manager and Mining Engineer.
