Further, in view of the above position, the information furnished under Rule 45(5) in the Annual return is construed as furnishing wrong or false information, which leads this office to advise the state government under rule 45 (7) to,-

(i) Order suspension of all mining operations in the mine and to revoke the order of suspension only after ensuring proper compliance;

- ii) Take action to initiate prosecution under these rules;
- (iii) Recommend termination of the mining lease, in case such suppression or misrepresentation of information indicates abetment or connivance of illegal mining;
- **03.** You are advised to rectify the above violations immediately and intimate the position to this office within **45** (**forty-five**) **days** from the date of issue of this letter.
