The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during Checkup inspection on 16/03/2022 by the undersigned in presence of Shri Manoj Shankar Singh, VP Mines.

	them to be laid out in a serial order with identification marks, showing the progressive

	During the inspection, it was observed that the core samples of boreholes were not kept
	systematically.

- 2. In response to violation letter dated 13/04/2022, a reply vides Letter No. KY/BMG-MHG/IBM/VIO/2022/01 dt-09/05/2022 has been received at this office on 17/05/2022 in which reply of violation done under rule 11(1) & 63(1) is not found satisfactory. Therefore, violations of rules 11(1) & 63(1) of MCDR-17 are still exist in above mentioned mine.
- 3. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 4. The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.
- 5. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.
- 6. Please note that no further notice will be given to you in this regard.
