

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during the inspection by Shri Sanjay M. Girhe, Regional Mining Geologist on 22.05.2021 in presence of Shri Vijay Gupta, Lessee's representative, Shri. Sandipan Sarkar, Qualified person, as under-:

Rule 11 (1)	According to this rule-No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Govi. pursuant to the provisions to caluse (b) of Sub Section (2) of Section 5 or approved by the competent authority of the Atomic Minerals Directorate for exploration and Researching respect of minerals specified in Part B of the First Schedule of the Act where the grade of such atomic minerals is equal to or above the threshold value limit declared under schedule-A of the Atomic Mineral Concession Rules 2016
	The Modification in approved Mining Plan of above mentioned mine was approved vide this office letter No-MP/Katni/Limestone/MPLN/MOD-01/2016-17 dated 17.12.2016. As per the future exploration programme, total 05 DTH boreholes were proposed during the approved plan period from 2016-17 to 2020-21. But, no boreholes were drilled against to these proposals during last 05 years.
Rule 26(2)	The holder of mining lease shall submit a yearly report as per the format specified before
	Ist July of every year setting forth the extent of projective and rehabilitative work carried out as envisaged in the approved mine closure plan, and if there is any deviation, reason
	thereof
	Report in prescribe Form for the year 2019-20 not submitted to the Regional Controller of
4	Mine, Jabalpur till the date of inspection.
Rule 28(1)	Subject to the provisions of section 4A, the holder of a mining lease shall send to the authorised officer, as the case may be, and the State Government a notice in Form E when the mining or mineral processing operations in the mine or part thereof are discontinued for a period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such temporary discontinuance.
	Mine was temporarily discontinued from 01.05.2019 to till 24.02.2021 but notice in this regard as required under this rule not submitted to the Regional Controller of Mines till the date of inspection.
Rule 32(1)(a)	The holder of mining lease shall keep a surface plan showing location and number of the
	boundary pillars along with its latitude and longitude values, every surface features within
	the mining lease boundaries, such as huilding, telephone, power transmission line, water
	pipe line, tramline, railway, road, rive, water course, reservoir, tank, borehole, shalf and incline opening, opencast working, dump and dumping ground, the waste land, forest,
	sanctuaries agriculture and grazing land and subsidence on the surface heneficiation plant
9	, tailing pond and other working within lease area;
	During the inspection, it was observed that limestone stacks on northern & southern part of Pit No-1 were not marked on surface Plan and thus violated above provisions of the rule.

- In this connection it is brought to your notice that the above violations constitute an offer 02 punishable under Rule 62 of MCDR-2017.
- Non compliance of the rule 11(1) of MCDR-2017 may lead to suspension of Mining of Lions 03. under the provisions of rule 11(2) of MCDR-2017.
- You are advised to rectify the above violations immediately and intimate the position to this office 04 within 45 (Forty Five) days from the date of issue of this letter.
