Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Jaribahal Iron Ore Mine in Keonjhar District of Odisha, over an extent of 106.533ha-Reg.

Sir.

The following provisions of Mineral Conservation & Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above mine during inspection on 12.07.2019 by undersigned accompanied by Shri S.K. Panda, Mine Manager.

Rule	Nature of Violation observed
26(2)	The yearly report in prescribed format on protective and rehabilitation works carried during the year 2018-19 has not been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Bhubaneswar, which ought to have been submitted before 1 <sup>st</sup> July 2019.
35(2)	The high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map, as on 31 <sup>st</sup> day of March 2019 for the financial year 2018-19 has not been submitted till date, which ought to have been before 1 <sup>st</sup> July 2019.

- 2. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017.
- 3. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
