Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Siljora-Kalimati Manganese & Iron Mine in Keonjhar District of Odisha, over an extent of 715.639ha-Reg.

Sir,

The following provisions of Mineral Conservation & Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above mine during inspection on 15.07.2019 by undersigned accompanied by Shri A.K. Roul General Manager (Mines) & Shri Ritesh Ranjan, Senior Manager (Geology).

Rule	Nature of Violation observed
35(2)	The high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map, as on 31 st day of March 2019 for the financial year 2018-19 has not been submitted till date, which ought to have been before 1 st July 2019.

2. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017. Besides, inability to comply the provisions of rule 11(1) also liable for suspension of mining operations under the provisions of rule 11(2) of MCDR, 2017.

3. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
